

Each day on this website, the QPA posts fine particle (PM_{2.5}) concentration data from its local monitoring station. The PM_{2.5} concentration reference standard is set out in the Clean Air Regulation (QLR Q-2, r 4.1). It takes into account monitoring site locations and the various potential sources of fine particles. 30 µg/m3 is the maximum 24-hour average concentration. More








