The AAPA, specifically the Latin-American Delegation, would like to extend their deepest gratitude to President Otto Perez Molina's Government and bureaucracy, as well as the The National Port Commission of Guatemala for their efforts and excellence in the organization of the XXI Latin American Congress of Ports, celebrated in Antigua Guatemala.

Concluding the Congress of April 12th, 2012, the AAPA Latin-American Delegation has great pleasure in submitting the following declaration of Guatemala:
