

Fleet Composition




21% of ships = 52% of available capacity

- Container trades will continue to grow long-term


U.S. Road and Rail Network





Port Capacity Utilization

East coast and gulf ports collectively have more physical capacity to expand than west coast ports.





Summary

- Ships will continue to get bigger

 - Expanded Panama Canal increases the options
- Container trade will continue to grow long-term
- Physical capacity expansion of ports has an upward limit
- Port productivity is key to ability to handle longterm container trade growth
