# National Mood






Government and politicians spiked as the top problem facing America in the wake of the government shutdown, reaching levels not seen since Watergate, although it has declined in importance since then.


Americans are intensely frustrated with their government and believe that the country is off on the wrong track.




Along with their general cynicism toward politics, this compounds the challenge of getting them to the polls in non-presidential elections.





Most Americans say the economy has gotten worse over the last four years, with barely one-in-three saying it has improved.






While it remains far below the levels experienced before the economic crash, the number of Americans saying now is a good time to find a quality job is inching upwards.

Thinking about the job situation in America today, would you say that it is now a good time or a bad time to find a quality job?







How would you rate the job Congress is doing? Do you approve or disapprove of the job they are doing?







Voters blame Congress but do not make exceptions for their members. Constituents of Democratic members are generally more supportive than those in Republican districts.

### How would you rate the job your member of Congress is doing?










Democrats saw a bump in their support during the government shutdown, but now the race for control of Congress is neck and neck.


What is your preference for the outcome of this year's congressional elections – a Congress controlled by Republicans or a Congress controlled by Democrats?

### Four Years After Enactment Health Care Law Remains Unpopular











While Americans overall support the health care reform law, the RAE widely support it and would rather see it implemented and fixed than repealed.










# The RAE, and African Americans in particular, favor Obamacare by wider margins.





### **Key Demographic Groups for 2014**


- There is always drop-off from presidential to off year elections. Drop-off in 2010 was larger than it had been previously, especially among voters of diverse ethnic backgrounds, younger voters, and unmarried voters (especially women), of whom more than 20 million voters did not return to the polls.
- 34 million voters are expected to drop off from 2012 to 2014.
- Of women drop-off voters, 55.4% are unmarried.
- Drop-off among voters in off year elections can have real impacts on elections.




## **National Drop-Off**

- Unmarried Women Voter drop-off: 32.9%
  - Est. 10.5 million votes
- African American Voter drop-off: 36.2%
  - Est. 6.5 million votes

- Latino Voter drop-off: 34.1%
  - Est. 3.8 million votes
- Under 30 Voter drop-off: 46.8%
  - Est. 9.6 million votes





### Key 2014 Issues

Although several pressing, and polarizing, issues are already on the table for 2014, the economy will be the central framework for voters in this election.





### Key 2014 Issues

- National perceptions of the **economy** always trail actual economic conditions, but better than expected growth in the fourth quarter of 2013 could help Democrats and President Obama's approval numbers. The disappearing middle class is one of the most powerful ways to express the widening gap between the very wealthy and the rest of the country.
- Both parties will try to position the debate over the economy on their own turf.
   Democrats will be pushing for a higher minimum wage, extending unemployment benefits, and equal pay laws for women. Republicans will blame Obamacare for holding back economic growth and the state of the deficit (despite the fact that it is shrinking rapidly, in large part as a result of the ACA). Voters rate the two parties equally on the economy right now.
- While a budget deal to avoid another shutdown was struck in December, the longterm debate goes on. The biggest impact of any future budget deals may be the extent to which Republican incumbents are made vulnerable to primary challengers who paint them as insufficiently conservative.




### Key 2014 Issues

- Social Security and Medicare are always top issues for midterm elections (in part because of the older electorate), and that will be the case again in 2014. Look for Democrats to advocate for expanding Social Security and for Republicans to portray themselves as protecting Medicare from Obamacare. Republicans remain vulnerable to attack for the embrace of the Ryan plan last cycle.
- **Obamacare** will undoubtedly be a motivating issue for conservative voters in 2014, but its importance to swing voters will be determined by how successfully the health insurance exchanges operate in the months to come and whether voters see their own health care costs start to settle. The key voters will be non-college, older, white women. While the Healthcare.gov fiasco may be over, enrollment issues for women and small businesses continue to tamp down any success the exchanges have seen.
- The Snowden revelations regarding the NSA and US surveillance will not go away in 2014 as
  the President and Congressional leaders call for a review of intelligence practices. However,
  so far few candidates have successfully turned this into an issue that pays political dividends.
- **Women's issues** will continue to play a prominent role in Congressional races, as GOP policies on health care, contraception, and equal pay will force the debate. And as we've seen in previous cycles, it only takes a few inarticulate candidates to bring these issues even more to the forefront.

Democrats are widely seen as the party that does a better job of looking out for the interests of women, the middle class, and the working poor, but the parties are even on the economy.








The wealthy are largely seen as doing very well in the current economy, while women, the middle class, and particularly those living in poverty are not doing well.




Given the option, most American support increasing the minimum wage, including a majority (51%) who support raising it to \$10.10 an hour or higher. Overall 69% of voters favor increasing the minimum wage.





# The Rising American Electorate will make up a clear majority of the eligible voters in 2016.


### **Voting Eligible Population in 2016**


### **2016 Republican Primary**





Should she choose to run, Hillary Clinton is the clear frontrunner for the Democratic nomination.


### **2016 Democratic Primary**


